5. Pre-bid meeting shall be held at Vyans Rural Municipality Office Sunsera, Darchula at 19-Sep-2023 (2080/06/02) at 12:00 Noon.
6. Electronic bids must be submitted to the office Vyans Rural Municipality Office Sunsera, Darchula through PPMO website www.bolpatra.gov.np. on or before 12:00 Noon on 05-Oct-2023(2080/06/18) . Bids received after this deadline will be rejected.
7. The bids will be opened in the presence of Bidders' representatives who choose to attend at 2:00 PM on 05-Oct-2023 (2080/06/18) at the office of Vyans Rural Municipality Office Sunsera, Darchula. Bids must be valid for a period of 120 Days after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum given above table which shall be valid for 30 days beyond the validity period of the bid
